External Funding Policy: Applying for Research & Contract Sponsored Funding

As a reminder, all faculty members and researchers are required to seek internal approvals before submitting their proposals for external funding. Any proposal submitted to the sponsoring agency without review by the necessary dept/college and OSP level review is not allowed. Funding Types Covered by this Policy

For all grant and contract submissions to external sponsors. This includes external funding for research, fee for service initiatives, professional development activities, special events such as conferences, and any other external funding sought after requiring contracted agreements and reporting.

The TC IRB Board Does Not Meet in August

Full Board protocols are reviewed once a month, except for August. The full Board will not meet in August but will reconvene in September. All exempt or expedited review category IRB protocols will be reviewed on a first-come-first-served basis.
