<u>Criteria for Scheduling Winter Intersession Oral Defenses</u>

Dissertation Oral Defenses are normally held in the Autumn Term and Spring Term. Upon recommendation from the Dissertation Sponsor and e-mail confirmation from all committee members that they are willing to serve on a defense during the Winter Intersession, a Dissertation Oral Defense may be scheduled during the Winter Intersession.

The Ed.D. Committee and **the Ph.D. Committee** authorizes the Office of Doctoral Studies (ODS) to review all petitions pertaining to the above conditions or others, which would precipitate exceptional urgency.

Instructions for Ed.D./Ed.D. CTAS Candidates

To obtain authorization for a Winter Intersession Dissertation Oral Defense, please follow the procedures below:

NOTE: The deadline for submission of the Ed.D./Ed.D. CTAS Intention to Defend the Dissertation for an Autumn 2022 term or 2022-23 Winter Intersession Defense is Thursday, September 15th, 2022. INTENTIONS RECEIVED AFTER THIS DEADLINE WILL BE CONSIDERED ON A CASE BY CASE BASIS.

- 1. The candidate submits the "Ed.D./Ed.D. CTAS Intention to Defend the Dissertation" form. The "Ed.D./Ed.D. CTAS Intention to Defend the Dissertation" form is available on the ODS website. Upon clearance for an Autumn 2022 defense, a 4th reader will be assigned and an "Ed. D. Application for Defense" form will be provided.
- 2. Should an Autumn 2022 defense need to be held in the Winter Intersession, in addition to completing the "Ed.D. Application for Defense" form, the candidate will provide a letter from the Dissertation Advisor supporting the rationale for the Winter Intersession defense.
- 3. Lastly, the candidate will provide an e-mail from each member of the Dissertation Oral Defense Committee stating their willingness to participate in the Winter Intersession Dissertation Oral Defense.

Instructions for Ph.D. Candidates

To obtain authorization for a Winter Intersession Dissertation Oral Defense, please follow the procedures below:

NOTE: The deadline for submission of the Ph.D. Intention to Defend the Dissertation for an Autumn 2022 term or 2022-23 Winter Intersession Defense is Thursday, September 15th, 2022. INTENTIONS RECEIVED AFTER THIS DEADLINE WILL BE CONSIDERED ON A CASE BY CASE BASIS.
